- The FY22 Enrollment Report was submitted to the State by today's deadline. The FY22 fundable credit enrollments total 92,926 credits, a decrease -3% from FY21 fundable credits.

- As of September 30, 2022, the College has earned 43% of budgeted revenues and expended 30% of budgeted expenditures.
- FY23 Summer enrollment is 21% above the budgeted goal, while FY23 Fall enrollment is -7% below the budgeted goal. The combined FY23 Fall and Summer tuition and fee revenue is \$63,000 above budget.
- Overall, revenue is up 4.5% compared to this time last year, expenditures are tracking 8.0% above this time last year, and the year to date margin is almost the same as the prior year to date.

The proceeds will benefit students in STEM majors.
