  - As of this draft, the College has achieved 102.8% of its budgeted revenues and expended 98.8% of its budgeted expenditures.
  - The unrestricted fund year-end adjustments are complete with the exception of the PERS pension reserve (pending the State publishing the employer billing).
  - The College will draw significantly less from the fund balance than originally budgeted for FY24. The final net margin will be determined once the fiscal year closing and audit are complete. The auditor's field work will begin this month.
- Trustee Parker motioned to approve Resolution #2; Trustee Castillo seconded. Motion carried.

Res. #47 FY25 Financial Statement for four months ended October 31, 2024.

- Trustee Kyle stated the following:
  - O As of October 31, 2024, the College has earned 45.9% of budgeted revenues and expended 36.3% of budgeted expenditures.
  - FY25 Summer enrollment is 7.3% above the budgeted goal, while Fall enrollment is -6.6% below budget. The net Summer and Fall credit tuition and fee revenue shortfall is (\$528,922).

- O Revenue is tracking -1.2% less than this time last year. Expenses are tracking 6.6% higher than last year, however, encumbrances are down -37%.
- o Combined, expenses plus encumbrances are down 1.6%.
- Trustee Parker motioned to approve Resolution #47; Trustee Torres seconded. Motion carried.
